## TEXAS SALES AND USE TAX EXEMPTION CERTIFICATE

I, the purchaser as named on this certificate, claim an exemption from payment of sales and use taxes from the purchase of the taxable items described as *The Social Book*, with updates and website access from seller, Social Book Enterprises LLC, dba *The Social Book*, and do claim this exemption because purchaser is a non-profit organization. I understand that I will be liable for payment of sales or use taxes which may become due for failure to comply with provisions of the Tax Code: Limited Sales, Excise and Use Tax Act; Municipal Sales and Use Tax Act; Sales and Use Taxes for Special Purpose Taxing Authorities; County Sales and Use Tax Act; County Health Services Sales and Use Tax; The Texas Health and Safety Code; Special Provisions Relating to Hospital Districts, Emergency Services Districts in counties with a population of 125,000 or less.

I understand that it is a criminal offense to give an exemption certificate to the seller for taxable items that I know, at the time of purchase, will be used in a manner other than that expressed in this certificate, and depending on the amount of tax evaded, may range from a Class C misdemeanor to a felony of the second degree.
